Types of organisation

There are different types of organisation categorised by different types of ownership.

1.Private sector - Private sector organisations are owned by individuals. These businesses are driven by profit. The profit from private sector organisations benefits the owners. Example- Infosys, Tata, Indigo airways Extra-marks etc.

2.Public sector- Public sector organisations are owned by the government. They provide goods and services for the benefit of the community. They are run by the government. They operate with money raised from taxes. Example- SBI, Electricity, Department, Water Supply Department, Railways.

3. Third sector-Third sector organisations are owned and run voluntarily by trustees. These organisations are not run by the need to make profit but by the need to help the community. They operate with money from donations and gifts. Any profits are reinvested in the organisation

Charitable/ Social welfare Organisation -A charitable organization or charity is an organization whose primary objectives is philanthropy(the practice of helping the poor and those in need, especially by giving money) and social well-being (e.g. educational, religious or other activities serving the public interest or common good). Example - Help

Age India, Goonj, Childline India Foundation.

Community groups

Community groups exist to provide a service for people. They are non-profit making and all of the profit goes back into the organisation to ensure it can keep running. Community centres or community halls are public locations where members of a community tend to gather for group activities, social support, public information, and other purposes. Example- Society groups, Student's club, Employee's Club

Social enterprise

A social enterprise is an organisation that exists with a clear goal to help the community but runs the organisation like a business. All profits are reinvested back into the organisation. Example- Co-operative organizations like Amul
